
### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 383

The Board of Directors of Harris County Municipal Utility District No. 383 will hold a regular meeting on **Wednesday, July 1, 2026, at 12:00 p.m.**, at the offices of Municipal Accounts & Consulting, L.P., 1281 Brittmoore Road, Houston, Texas 77043, to discuss and, if appropriate, act upon the following items:

1. Receive comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
  - a. Approve minutes.
  - b. Development in the District and elsewhere in Gleannloch Farms.
  - c. Tax assessment and collection matters, including delinquent tax collections and payment of tax bills.
  - d. Financial and bookkeeping matters, including payment of bills and review of investments.
  - e. Operation of District facilities, including:
    - i. billings, repairs and maintenance, customer correspondence, and message language on water bills; and
    - ii. sanitary sewer video inspection program and repairs.
  - f. District park matters, community improvement projects, and related coordination with community association.
  - g. Channel and pond maintenance, including detention and drainage facilities report.
  - h. District website and communication matters.

  - b. Garbage and recycling matters, including annual CPI adjustment.
  - c. Approve audit for fiscal year end March 31, 2026.

  - bb. wastewater treatment plant improvements;
  - cc. water plant nos. 1 and 2 improvements;
  - dd. lift station nos. 1 and 2 improvements;
- iv. deeds, easements, execution of plats, consents to encroachment requests for annexation and/or service, utility commitment letters, and wastewater service contracts;
- v. capital improvement plan, including project funding;
- vi. District drainage matters;
- vii. NewQuest detention pond, including maintenance;
- viii. update on preparation of bond application no. 13;
- ix. other engineering matters, including:
  - aa. nutria removal; and
  - bb. Boudreaux Road realignment.
- i. Additional financial and bookkeeping matters including:
  - i. discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.
- j. North Harris County Regional Water Authority (“NHCRWA”) matters.
- k. Additional operating matters, including:
  - i. Phase 1 sanitary sewer manhole survey;
  - ii. Phase 5 sanitary sewer repairs;
  - iii. fire hydrant repairs;
  - iv. hearing on termination of water and sewer service to delinquent customers and authorize termination of service;
  - v. write-off of delinquent charges; and
  - vi. annual CPI adjustment to operator rates.
- l. Approve Interlocal Agreement with Harris-Galveston Subsidence District for the Water Conservation School Program.
- m. Authorize renewal of District’s insurance policies, including review of engineer’s list of District facilities to be insured.
- n. Reports from Directors and District consultants on District matters.
